Privacy Notice for MobiliseYourCity Webinars

Introduction

MobiliseYourCity is committed to protecting your personal data and respecting your privacy. This Privacy Notice explains how we collect, use, and protect the personal data you provide when registering for and participating in our webinars. It also outlines your rights under the General Data Protection Regulation (GDPR).

What Data We Collect

When you register for a webinar, we collect the following personal data: Full name, email address, gender (optional), city, country/region, organisation (optional), type of organization, job title, recording information (during the webinar, recordings may capture your name and/or image).

How We Use Your Data

We use the personal data collected for the following purposes:

- 1. **Event Registration and Participation**: To manage your registration and facilitate your participation in the webinar.
- 2. Communication: To send you reminders, updates, and post-event materials.
- 3. **Improvement**: To improve the webinar experience based on feedback and analysis.
- 4. **Recording**: To publish the webinar recording, which may include your name or image, on our YouTube page.

Legal Basis for Processing

We process your data under the following legal bases:

- **Performance of a Contract**: To manage your registration and participation in the webinar.
- **Legitimate Interests**: To collect information such as your type of organisation and location to improve the webinar experience, and to gather feedback for internal analysis.
- **Consent**: To include your name or image in the webinar recording published online.

Data Sharing

We do not share your personal data with third parties. However, the data is collected through Microsoft Teams, which processes it as part of its service. Microsoft Teams has its own privacy notice and consent process for their data handling. Aggregate, anonymised data may be shared with our member organisations (e.g., CODATU, GIZ) for analysis and service improvement purposes.

Retention Period

Your personal data will be retained for a maximum of two years after the webinar. This allows us to conduct analysis to improve our future webinars. After this period, your data will be securely deleted or anonymised.

International Data Transfers

No personal data will be transferred outside the EU/EEA. Microsoft Teams processes the data in accordance with its own privacy notice, which complies with GDPR standards. Participants must agree to Microsoft's terms when completing the registration form.

Your Rights

Under GDPR, you have the following rights regarding your personal data:

- Access: Request a copy of your data.
- **Rectification**: Correct any inaccuracies in your data.
- Erasure: Request the deletion of your data ("Right to be forgotten").
- **Restriction**: Restrict the processing of your data.
- **Objection**: Object to processing based on legitimate interests.
- Data Portability: Receive your data in a portable format.
